Hôtel Don Miguel in Santa Susanna : November 18th, 2021

The meeting was opened at 11 a.m. by Mr. Claude Azéma, Delegate of the Provisional Bureau set up at the time of the deposit of the statutes of the World Federation with the commercial register of the canton of Vaud by the Cabinet Carrard, lawyers in Lausanne; and Chairman of the meeting.

WELCOME SPEECH

The President is happy to have been able to convene this first General Assembly of the World Pétanque and Bowl Federation (WPBF) which will mark an important step in the structuring of the world of bowls at the international level as well as in its consideration and representation within the World and Olympic sports movement.

He has the pleasure to greet the presence or the representation of many national federations of Lyonnaise, some of which also practice Raffa, which were added to those which took part in the International Congress of the FIPJP, several of which also regroup two or three disciplines. He particularly thanks Marcelo Bravo, Argentinean vice-president of the FIB, who worked hard in this sense, in liaison with Frank Guzman, President of Panam.

Finally, he underlines the presence of Mr. Frédéric Ruis, President of the International Bowls Federation and of its Secretary General, Pascal Fernandez, to whom he wishes a warm welcome. *(Applause)*

HISTORY AND MORAL REPORT

The President indicated first of all that he would not go back over the history of the creation of the World Federation since this was the subject of a detailed presentation during the FIPJP Congress and that this text would be attached to the minutes of this General Assembly. It will rather focus on the continuation of the creation itself by insisting on the motivations of the change and on the progress that it represents, whether it is a question of the governance of the World Federation or of its international relations, while allowing each discipline to remain master of the technical and organisational aspects of its events.

As far as the motivations are concerned, the change was guided by the desire to obtain a harmonious functioning of the world bodies of the bowls world on the sporting level as well as in the administrative field, and in its relations with the world sporting and Olympic institutions; to answer the requirements of good governance wanted by the IOC and which should prevail in all the reforms concerning the international federations; thus to ensure more democracy as well in the process of election of the leaders as in the organised activities.

In particular, it was necessary to move away from an oligarchic designation of leaders to a normal electoral process, moving from a confederation based on disciplines to a true World Federation based on national federations. Thus, instead of the designation of a President by 9 persons nominated by the three member IFs and constituting the Management Committee, there will henceforth be an election of a President and of the members of the Management Committee by all the member federations at the rate of one federation per country, except for exceptions admitted at the beginning to allow for greater diversification, with each one having one vote.

It was also desirable to move away from an "egalitarian" representation of the disciplines because if equal treatment must be ensured, as for the different disciplines in the IF of air sports, their importance, real or supposed - or even fictitious! - should not affect the composition of the governing bodies.

At the same time, the statutes have established specific structures for each discipline that could be practiced by the member national federations: the Colleges which will allow the bodies currently

managing certain disciplines to retain their independence in many areas: rules of play and technical texts; disciplinary championships, internal organisation with a president and, if they so wish, a Management Committee elected by their members who are up to date with their memberships; the possibility of fixing memberships that are specific to the discipline

On the other hand, neither the Colleges nor the disciplines will have any power in the appointment of members of the WPBF Board. This will be done in a General Assembly with all the national federations. The Colleges will be represented by one of their leaders so that they can present their specific requests or problems; but the latter will only have a consultative voice, except during the transitional period of the first two years when the presidents of the Colleges corresponding to the three associated members will have a deliberative voice.

If other bowls disciplines wished to join us, it would be possible to create special colleges provided that they were already organised at international level. However, before taking such a decision, the Bureau of the World Federation would consult the IOC, which is very attached to the notion of a recognised discipline.

Other Colleges will concern specific aspects of our disciplines. For example, there will be a College for the practice of disabled people and another to deal with the practice in e-sport way.

On the other hand, only the World Federation will be in contact with the international sports organisations and will be represented within them, in particular the AGISF (General Association of International Sports Federations), the ARISF (Association of International Sports Federations recognised by the IOC) and the IWGA (World Games Association). Through it, all member disciplines will be able, sometimes under certain conditions, to be present in major international multi-sport, world, continental or regional events.

The World Federation will also manage relations with WADA (the World Anti-Doping Agency), which will be a great help to the current federations, even if this will probably require an agreement with the ITA (International Testing Agency), as this management is so complex. As already mentioned, it is thanks to his staff, the AGIFS lawyer and the WADA representative in Lausanne, that we managed in extremis, in August, to have an updated Anti-Doping Code in conformity with the 2021 Code, thus avoiding being on the black list of non-compliant associations!

In this matter you will have the pleasure of hearing a presentation by Gabriel Zangenfeind who will focus on the information and education aspects of ITA and who will be available this afternoon and tomorrow to meet you and answer your questions.

Similarly, it is the World Federation that will sign the M.O.U. (Memory Of Understanding) with Olympic Channel, our friendly correspondent holding the text ready overnight to move from CMSB to the World Federation.

In the same way we have already elaborated the Code of Discipline, whose content may evolve over the years, a Code of Ethics at the initiative of Pascal Hernandez, a financial regulation and an organisational regulation, the official name of the internal regulation. You will receive all these texts in French and English with the minutes of this General Assembly.

This evolution will allow us to improve governance, to better bring together the bowls disciplines, to ensure a greater participation of national federations in the choice of leaders and to modernise our structures. In particular, the General Assembly, as today, will include all the member National Federations, instead of being constituted only by the three presidents of the International Federations members of the former CMSB.

We have also taken advantage of this reorganisation to introduce new provisions, in particular by imposing the presence of at least four women on the Management Committee of the World Federation, whereas no such provision existed in the CMSB, whose Management Committee never included a single woman. We will not stop there as there will be a Women's Commission within the World Federation and the promotion of women in the governing bodies will be one of our themes in our conventions to be supported by the IOC along with training and the fight against doping.

We are also advocating the creation of an athletes' commission with a representative attending the Management Committee meetings.

Since its admission to the AGFIS/GAISF, notified on 7 July by a letter from its President, Raffaele Chiulli, a great man of international sport, the World Federation has taken the places occupied by the CMSB within the ARISF and the IWGA, with which we have never ceased to cooperate by continuing to pay the membership fees in 2020 and 2021, as the World Games have kept in their programme the Lyonnaise and Pétanque events for the Women.

If the notion of discipline, which was preponderant apart from any other consideration, will remain in the structure and functioning, it will no longer be the key to the appointment of leaders, which can only be done by the general assembly.

It should also be noted that some forty national federations already have several bowls disciplines within them - including others, but those where all three are really practised are rare - and send teams to the various corresponding international competitions, which has never involved the recognition of these disciplines.

To conclude, it is necessary to underline the disappearance of two ridiculous and obsolete provisions: the one that allowed the decisions of the Management Committee to be annulled when all its members were not present or represented; the one that provided that, in case of withdrawal of one of the three founding federations, the CMSB was automatically dissolved. From now on, the dissolution of the World Federation can only be pronounced during a General Assembly convened for this purpose and with a qualified majority.

Finally, as everyone has seen, the World Federation is under Swiss law and has its headquarters in Switzerland, at the Maison Communale de Prilly, thanks to the benevolence of its mayor, who is an ardent defender of Pétanque and still wishes to be able to organise a world championship at his home in the Olympic rink of the Vaudoise Arena. It will also have its bank account in Swiss Francs in Lausanne but it is necessary to wait for the constitution of its Board of Directors to be able to engage the steps with the statutory authorizations required.

The evolution is underway and everyone will be able to see this when reading the documents already sent and which will be attached to these minutes. There will be a lot of work left for the future Management Committee, whose members will be elected and who will hold its first meeting at the very beginning of the year once the administrative formalities have been completed and the agenda prepared. (*Applause*)

FINANCIAL STATEMENT

The President emphasised that there were obviously no direct financial movements from the World Federation, as it had not been able to benefit from any resources. Nevertheless it was necessary to face certain expenses, in particular the lawyers' fees and the contributions to the international sports authorities. For the latter, the FIPJP made the payments in order to ensure the presence of the World Federation in particular at the World Games, as it had done in 2020, but this expenditure was then reimbursed thanks to the balance of the CMSB account.

The World Federation did not yet have a bank account, as opening one required a resolution of the Bureau giving signing authority to certain persons. It would soon be opened in Lausanne in the agency of a bank with a branch in Monaco if the General Assembly accepted the proposal to elect Jean-Luc Fuentes as General Treasurer.

Given the origin of the funds used, the latter has worked closely with Michel Signaire on the accounts of the FIPJP and the World Federation.

Mr Jean-Luc Fuentes, *Acting Treasurer*, can only comment very briefly on the document which is attached to the minutes.

The main expenses were constituted by the contributions to GAISF and IWGA for a total of 6,000 CHF, then by the payment of lawyers' fees for the consultancy activity, the construction, the management and the deposit of the statutes, that is to say approximately 11,500 CHF. In both cases they were covered by advances from the FIPJP.

The other expenses, mainly travel and meeting costs, were covered by the concerned parties. The overall sum is therefore shown as both income and expenditure.

This budget is still being implemented and one can add to it on the one hand the expenses recorded in advance, i.e. the reimbursement of the expenses ensured by the FIPJP, i.e. approximately 17,500 CHF, and on the other hand the provisional receipts: 6,000 € of the contributions of the three "associated members" and 4,500 to 5,000 € of contribution of the national federations.

He could not say more and was waiting for the account to be opened before launching the call for memberships.

The President thanked Jean-Luc and Michel Signaire, who had managed the accounts together and in parallel, which had sometimes seemed like a balancing act. (*Applause*).

(In the absence of any interventions, the financial report is unanimously approved).

ADOPTION OF THE STATUTES

The President recalled that the statutes of the World Federation had been the subject of several months of work and numerous exchanges, first with the Cabinet Carrard from July 2020, then with the GAISF lawyers, in particular Davide Delfini, whom we cannot thank enough for the work he had done voluntarily and for the judicious advice he had given as a perfect specialist of the IOC's expectations on the subject.

After two final meetings with representatives of the CBI, the FIB and the FIPJP, the final version was entrusted to the Cabinet Carrard, which registered it with the Commercial Register of the Canton of Vaud on 3rd of May. We decided that these statutes would be governed by Swiss law and that the headquarters of the new world federation would be in Lausanne so that we would be closer not only physically but also symbolically to the centre of the world's sporting institutions, including of course the IOC.

We then informed GAISF of the changes that had occurred in the governance of the sport of boules at international level and its President, Raffaele Chiulli, considered that it was not necessary to initiate a recognition process and that it was judicious to consider that the new World Federation was taking over from the CMSB with major changes in its governance.

He referred the matter to the Admissions Committee, which had issued an opinion along these lines, indicating that it was therefore not necessary to resort to a vote at the General Assembly to confirm the World Federation's affiliation. At the request of President Chiulli, the GAISF Council members followed this advice and considered that the WPBF was perfectly entitled to take over from the CMSB both in their organisation and in those of which the CMSB was a member, in particular ARISF and IWGA. He notified them and the IOC directly so that they could possibly implement their own recognition procedures.

As there is general agreement on these statutes, it would be wise to adopt them today without modification, which will not prevent them from being reviewed, completed or modified at a later date if the need arises on certain points.

(In the absence of opposition, the statutes are adopted unanimously – Applause)

The President - I would like to thank you and all those who have helped in the realisation of this innovative and reforming project. To those I have already mentioned I would like to add Philippe Gueisbuhler, the former Director General of GAISF, who left us at the end of last year to join the FIS, the International Ski Federation, because he was at the origin of the approach followed to reform our organisation in which he accompanied us until his departure.

Attached to this report are all the texts that I have already prepared: the statutes, of course, but also the organisational regulations, the Code of Ethics, the Code of Discipline, the financial regulations and the scale of fees.

SPEECH BY GABRIEL ZANGENFEIND (ITA)

The President : - I am pleased to welcome Gabriel, who has been sent to us by the Education and Training sector of the ITA, the International Testing Agency. This is an independent organisation, a non-profit foundation, which implements anti-doping programmes for international sports federations, organisers of major events or any other anti-doping organisation requiring support.

This function was previously carried out by a body under the umbrella of Sport Accord - the Doping Free Sport Unit (DFSU) - but, given the potential risks of a lack of independence, it was deemed appropriate to entrust this task to an organisation outside the Olympic movement. Several solutions were considered, including the use of the UCI's Anti-Doping Foundation, the International Cycling Union, but in the end the choice was made to transform the DFSU into an independent agency.

The ITA was thus created in 2018 under the supervision of the World Anti-Doping Agency (WADA) and the International Olympic Committee (IOC) in order to promote independence, expertise and transparency in the global fight against doping, and I was therefore reunited with specialists with whom I had worked on the subject of doping when I took over the presidency of the CMSB, including Matteo Vallini, who had done us a great service at the time.

In view of the serious difficulties that we have experienced since the beginning of this year and which risked having us excluded from the federations in conformity with the WADA Code, I asked Matteo to meet him to discuss the subject, which we did on three occasions, including with his General Director, Benjamin Cohen.

With their collaboration, Davide Delfini, who has also worked in this field, and Laetitia Zumbrunnen, who is in charge of relations with the international federations on behalf of WADA, enabled us to present and have accepted in a few days instead of several weeks, a compendium of

our anti-doping rules that is perfectly in line with the WADA Code 2021. For your information, it will also be annexed to these minutes.

On the basis of our discussions, the ITA, chaired by Valérie Fourneyron, former French Minister of Sport, will propose a memorandum of understanding and, above all, assistance over four years, which is essential given our lack of means and human resources in this area.

They also arranged for me to meet the person in charge of the Education and Training sector, Mrs. Olya Abasolo, with whom we discussed the various possibilities of training and information actions for the federations, and in a few days we arranged for Gabriel to come to our general assembly, to whom I give the floor.

Mr. Gabriel Zanenfeind, *ITA Delegate*, thanked the WPBF to let him participate to its General assembly and to give him the opportunity to introduce his institution and all the services it may provide to our members federation :

After the President's speech he adds the International Testing Agency role is to make sure that sport is clean and fair. We believe in everyone having the same chance to succeed, and that means leading the way in the fight against doping. Our comprehensive and innovative anti-doping programs help you to ensure that you can run your competitions and events with complete confidence whilst protecting your athletes and your sport.

WADA is responsible for the world anti-doping code, the key document that harmonises policies, regulations and processes in anti-doping for all sports and within all countries. We then have the International Federations and National Anti-Doping Organisations' anti-doping rules sitting alongside the code. Then, the code works in connection with 8 international standards – these are adopted by WADA and just like the code, are directly applicable to all anti-doping organisations. These are more technical documents which define all the requirements of an anti-doping program.

Doping is defined as the occurrence of one or more of the anti-doping rule violations set forth in Article 2.1 through Article 2.11 of the Code.

All members of the sports community are subject to the global anti-doping rules as outlined in the world anti-doping code and the international standards.

So there are eleven anti-doping rule violations, all applying to athletes, of which seven apply also to athlete support personnel and other members of the sport community.

These rules are in place to protect athletes' health and their right to clean, fair competition.

The prohibited list is a document which lists substances and methods prohibited in sport. It is produced by WADA and updated at least annually.

A substance or a method can be added to the prohibited list if it is deemed to meet at least two of the following three criteria:

It has the potential to enhance or enhances sport performance.

Use of the substance or method represents an actual or potential health risk to the athlete.

Use of the substance or method violates the spirit of sport.

Ask your doctor or pharmacist, check with your National Anti-Doping Organisation and use reliable online resources such as Globaldro are just some tips to help check medications.

The World Anti-Doping Agency provides specific guidance as to what is required for a TUE to be granted in an official document called the international standard for therapeutic use exemptions. The requirements are as follows:

The athlete's health will be significantly impaired if they do not take the substance

The substance does not enhance the athlete's performance beyond what brings them back to normal health

There are no alternative permitted treatments available

The need for the use of the prohibited substance is not resulting from prior use of a prohibited substance

What are the risks of taking supplements?

Firstly, supplements may be mislabelled – ingredients are not properly listed, and the supplement may contain a prohibited substance that is not listed on the label.

Contamination is another real risk of using supplements.

Supplements can also pose health risks.

It is important to remember that no supplement is 100% risk-free, and we will speak about what you can do to manage risks.

There are many independent companies that test supplements around the world, and on your screen you can see a few that we recommend. You can also check with your NADO for their recommendation – there may be a country and language-specific tool that will best suit your needs.

It is important to understand the key steps of the Doping Control Process. The ITA has produced a short guide about this in eleven languages.

M.Zanenfeind then commented on a powerpoint which is attached and thanked the Assembly for its attendance. (*Applause*)

The President thanked Mr Zanenfeind for his speech and announced that a small stand is available in the foyer of the hotel where Mr Zaneinfeld will be present for two days to advice and give more details informations for federations which are interested in cooperation with ITA.

ELECTIONS

The President wished to recall various information relating to these elections, although they had already been circulated in writing.

The General Assembly will first elect the President, then the Secretary General and the Treasurer, and finally the members of the Executive Committee.

In order to simplify the procedures, each voter will only have to move once and will be able to deposit his ballot papers successively in the ballot boxes assigned to each ballot and located on the right of the podium. The ballot papers were distributed to the federations when the attendance sheet was signed.

Even if there is only one candidate per position for President, Secretary General and Treasurer, each must obtain an absolute majority of the votes cast to be elected.

The election of the members of the Management Committee shall be conducted by means of a one-ballot, multi-member ballot. As the Presidents of the three Colleges of Associate Members have already been appointed by the Colleges, after the election of the Presidential trio, there will be only 9 vacancies to complete the Management Committee, including at least 4 Women.

Consequently, the first 4 women will be proclaimed elected, followed by the 5 candidates who have obtained the most votes.

Mutlu Türkmen (CBI - Raffa), Frédéric Ruis (FIB - Lyonnaise) and Gérard Schneider (FIPJP - Pétanque) have been nominated by their colleges. They will be members of the Executive Committee with voting rights for two years. At the end of 2023, in accordance with the statutes, these three positions will be renewed in an open election and the three Presidents of the Colleges concerned will remain members of the Executive Committee, but in an advisory capacity only.

Finally, he informed the General Assembly that Mr. Khalid El Mansouri from Morocco had withdrawn his candidature.

(A physical presentation of the candidates present was made).

The President then asked for volunteers to act as tellers. Under the direction of Mr Borré, President of the polling station, assisted by Régine, the volunteers would be Alisson Swiffin (Scotland), Jean-Yves Robic (Wales) and Georges Gebrael (Lebanon)

He asked them to take their places behind the ballot boxes and declared the vote open

The elected candidates will be members of the World Petanque and Bowl Federation's Excom for a four-year term, until the end of 2025. (*Applause*)

I invite Claude to take over the direction of the debates.

The President first of all thanked the General Assembly for the confidence placed in the first management team of the World Federation and congratulated Reinold for the smooth running of the electoral process.

He gave the floor to Mr. Frédéric Ruis, President of the Fédération Internationale de Boules (FIB)

Mr. Frédéric Ruis, *FIB President*, first introduced himself to the participants of the General Assembly by indicating that he has been President of the International Bowls Federation for five years and that he was re-elected for four years in November at the General Assembly held in Martigues, France.

He has always been an advocate of the unity of boules sports in the world as this is a factor of development for all disciplines, especially for those that are less prominent, such as the Lyonnaise. This collaboration has been effective and productive in Taipei, for example, where a Lyonnaise training course was organised within the Pétanque Federation with the help of the FIPJP.

Elsewhere it can be the reverse, as is currently the case in South America where Pétanque is integrated into the national federations of Boccas under the aegis of Marcelo Bravo.

During the preparation for the creation of the World Federation, no original solution was found for its name and the members of the FIB would have preferred to speak only of boules, a generic term for all disciplines, without adding the word Pétanque specifically.

The creation of this federation is a very good thing because it will allow us to be well present at the international level, in particular with the Olympic authorities as well as in many multi-sport competitions and he thanked Claude for the work accomplished.

He fully supports the evolution that the WPBF represents compared to the former CMSB and he is ready, with his collaborators, to work in the path traced. (*Applause.*)

The President thanked Frédéric for his presence with the FIB General Secretary, Pascal Hernandez, for his collaboration and for his appreciation of the evolution of the boules structures at the international level.

He added that Pétanque had worked well for decades under the term "boules" for the CMSB without taking offence when it was the only one of the three disciplines not to have the word "boule" in the name of its international federation. From now on all three will be concerned in the name of the World Federation.

He also thanked all the representatives of the federations for their participation by reminding them that the access to the various commissions which will be set up within the WPBF will be open. Delegates of the federations will be able to join them after the secretary has sent the list and the competences whose creation will have been ratified by the Excom.


Finally, he congratulated the interpreters for their remarkable work, which had greatly facilitated the General Assembly and enabled everyone to understand the speeches. (*Applause*)

As the agenda is finished and no one asks for the floor, he closes the General Assembly 2021 of the WPBF.

(The meeting was closed at 1 p.m.)
